The Special City Election to fill the vacant Council seat in Ward Five (5) will be held on Saturday, September 12, 2015,. The individual elected to fill the vacancy will serve the remainder of the existing term, expiring in May 2017.

The deadline for filing for Candidacy for this election is 5:00 p.m., Friday, August 7, 2015.
